At the 1996 SPP Fall meeting in Houston, a long term planning retreat commenced with a one and a half day session, with the goal of developing a strategic plan for the Society. Dr. **Tom Stocker** chaired the session. The attendees agreed on seven specific initiatives:

1. Convince others of the unique value of pediatric pathology
2. Enhance our discipline by initiatives targeting non-pediatric pathology audiences.
3. Define more clearly the roles of Society leadership.
4. Continue strategic planning as an integral part of our Council's business.
5. Expand membership of the Society by creating a "broader tent" with easier entry.
6. Apply new communication technologies to education by creating a new committee.
7. Enhance research by expanding and defining Research Committee activities.

Small groups developed specific objectives for each of these initiatives. The committee's efforts were abetted by SPP President **John Buchino** and President-elect **Jim Dimmick**, as well as various committee chairs and council members. The group was smiling in the end-of meeting group photo, a testament to a successful retreat.

## SPP Fall Meeting Recap

### Fall Meeting Summary and Highlights

The Fall Meeting, held in a virtual format, was well-attended with 271 participants engaging via the meeting website. Please see the Research & Awards Committee report below for award winners.

Although the stars failed to align for a planned return to live meetings, the virtual Fall Meeting was highly educational and enjoyable.

As usual, Committee meetings took place first, from October 5 through 7, 2021. The virtual Fall Meeting was held on October 8 and 9, 2021. I found the meeting website comprehensive and easily navigable, with a few highlights mentioned below

SPP President **Debra Heller** kicked the meeting off with the President's Welcome.

The COG Update on Lymphomas was provided by **Rodney Miles**, who discussed two new provisional entities in the 2017 WHO Classification, Burkitt-like lymphoma with 11q aberration and large B-cell lymphoma with IRF4 rearrangement, and two previously provisional entities that now have definite status, ALK-negative ALCL and pediatric-type follicular lymphoma. He also gave an update on lymphoma treatment and biology studies from the COG Non-Hodgkin Lymphoma Committee, including an open study of minimal disseminated disease in B-lymphoblastic lymphoma.

Next up was a WHO Blue Books tag team with an update on the upcoming volume dedicated to pediatric tumors (or is that paediatric tumours?). **Jason Jarzembowski** discussed the WHO Blue Book approach to classification and diagnosis and described the need and rationale for a pediatric volume. **Rita Alaggio** followed up with a discussion of the move from morphologic classification to molecular definition of tumors. She described several advances reflected in the upcoming volume, including the alignment of the WHO and ISSVA classifications of benign vascular lesions and the incorporation of pediatric NTRK-rearranged spindle cell neoplasms into the category of myofibroblastic tumors. She provided insights into changes affecting the classification of CNS tumors including the role of DNA methylation analysis, the introduction of "pediatric-type" glioma categories, and the inclusion of novel tumor types with molecular definitions. She also foreshadowed upcoming changes in the WHO classification of hematolymphoid neoplasms. **Miguel Reyes-Múgica** closed this highly informative session with a review of the efforts involved in producing the pediatric volume and an explanation for the importance of a developmental approach to classification of pediatric tumors.

Although virtual meetings can't match the opportunity a live meeting provides for interacting and rubbing elbows with fellow pediatric pathologists, one of the built-in treats for this meeting was the use of Zoom networking breaks on both days. I found these to be lively sessions that drew a varied cross-section of the Society, from trainees to academic and private practice pathologists to Society officers and directors. The topics of conversation ranged from the impact of COVID-19 on pathology training to development of a core online curriculum for pediatric pathology to the use of voice recognition software in practice. **Jeff Goldstein**, a past President of the SPP, deserves a special mention for taking on the role of unofficial host for these sessions, keeping the conversation flowing and making sure all the attendees felt included. **Aliya Husain** joined in on Saturday and helped ensure a welcoming and interactive session.



The first Platform Session was devoted to perinatal pathology. As one might expect, the pathology of SARS-CoV-2 loomed large, but many topics received thoughtful attention. The second Platform Session continued with perinatal topics and segued smoothly into pediatric topics including bone marrow transplant complications, autopsy, and even cryopreservation. As **Jason Jarzembowski** observed in his Daily Wrap-Up email at the end of the first day, there was a heartening range of presenters, from students to trainees to senior pathologists, and many institutions were represented.

The first day of the meeting was capped by a fascinating Lotte Strauss Lecture from **Nya Nelson**, whose talk spanned from histopathology of congenital pulmonary airway malformations to molecular pathology, highlighting the role and clinical implications of KRAS codon 12 mutations in the development of type 1 and 3 congenital pulmonary airway malformations.

The second day of the meeting began with a Platform Session dedicated to neoplasia and featured talks on a broad range of pediatric tumor types, from hepatic tumors to leukemias. The Fall Symposium offered a highly engaging group of speakers, each providing a different window on inflammatory bowel disease. **Thomas Walters** provided a clinical perspective, **William DePaolo** discussed the interplay between the microbiome and inflammatory bowel disease, **Judith Kelsen** focused on very early onset inflammatory bowel disease, and **Pierre Russo** rounded out the Symposium by discussing difficulties in the pathologic diagnosis of inflammatory bowel disease, unusual features of ulcerative colitis one might encounter, and ongoing issues in the use of histologic biopsies in disease management.

The interactive poster session was another built-in treat of the meeting website. Presenters had the option to pre-record an audio accompaniment, and poster viewers could engage the presenters with online questions and answers, as well as download and even tweet about posters that caught their fancy. It was not the same as meeting and chatting with presenters in person, but these features really helped to bridge the distance.

One of the very few technical issues I encountered during the meeting interfered with my ability to view the Awards Presentation. Fortunately, the video with Research and Awards Committee Chair **Jefferson Terry** was subsequently available on the meeting website until November 9. To avoid redundancy, I will leave the discussion of the awards and the award winners to his committee report, found elsewhere in the Newsletter.

As the meeting began to wind down, **Debra Heller**, SPP President, provided parting words and offered thanks to all involved.

The Perinatal Slide Session brought the meeting to a satisfying close, offering a wide variety of very interesting cases. For the first time, the Perinatal Session offered CME credit, which is richly deserved for this very educational and popular pillar of the Fall Meeting.

If you were able to join in for the Fall Meeting, I hope that this is a useful refresher of some highlights. If you were unable to attend, I hope that this review brings you up to speed and whets your appetite to attend the Spring Meeting in person. Until then, be well!

#### **Highlights from Last Quarter**

- The Fellowship Committee has requested updates from Program Directors for the website and a list of current fellows for 2021 and incoming fellows for 2022.

- On October 7<sup>th</sup>, the Fellowship Committee met during the SPP’s virtual Fall Meeting. American Board of Pathology (ABP) business included updates on continued certification, related survey questions, and position on virtual examination. Accreditation Council for Continuing Medical Examination (ACCME) Milestones were also discussed. In new business, the committee discussed APC collaboration, a fellowship match opportunity, unfilled fellowship positions, and a possible SPP fellowship recruitment and enhancement initiative.

### **Finance Committee**

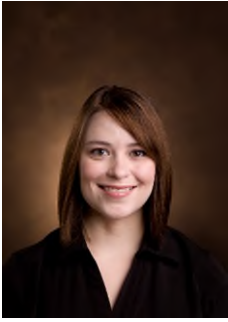
#### **Highlights from Last Quarter**

- The committee finalized and approved a survey assessing the role of **electron microscopy** in pediatric pathology practice.
  - This survey was sent out to the SPP membership and there were ~90 unique institutional responses, including international respondents.
  - The committee analyze these results in the coming months.
- The committee finalized revisions on an **appendectomy survey** to be sent to membership in the coming months.
  - This survey was drafted by Dr. Robyn Reed in order to ascertain current practice in handling and reporting appendectomy specimens.
  - It will be presented to the Executive Committee for approval.

### **Announcements and Upcoming Initiatives**

- The committee is starting a new project cataloging and reviewing recommendations on molecular and genomic test utilization in pediatric solid tumors.
- There is an **on-going brain tumor molecular testing guidelines project**, undertaken in collaboration with the Education Committee.
- The members would like to increase discussion among SPP members involved in different sub-specialties and across other specialty medical and professional organizations.

### **Publications Committee**

#### **Highlights from Last Quarter**

- The Publications Committee gave input on the SAGE/SPP contract renewal, which is now moving to the contracting stage. The contract includes an online-only subscription option for the *PDP Journal*.

- The Publications Committee provided input on the developed *Editor-in-Chief* contract between the SPP and Dr. **Pierre Russo**. A group of volunteers reviewed the contract draft and provided their feedback for consideration by SPP leadership.
- The SAGE year to date report, indicating the overall health and improvement areas of journal, was given at the Publications Committee meeting. The *PDP* had a higher impact factor than ever before, and the review date to first decision has been reduced.

### **Announcements and Upcoming Initiatives**

- Dr. **Monique De Paepe**'s term as the Chair of the Publications Committee will end in March 2022, she has requested that if anyone is interested in taking over, to kindly reach out to the SPP.
- Dr. **Pierre Russo** is pleased to continue in his role of *Editor-in-Chief* for the *PDP* for another 5-years.
- The Publications Committee is interested in considering some sponsorship for open-access publication fees.
- The Publications Committee discussed the current single-anonymized review process and determined that this process will continue for now. We decided that the SPP would proceed with use of the term "anonymized" instead of the outdated "blinded".
- We will continue to pursue the goals of the *PDP*, including maintaining high publishing standards, expanding journal discoverability, lowering the review turnaround time, sustaining paper flow, increasing the impact factor, and expanding diversification of the editorial board.
